All India Women's Conference (AIWC), is India's premier NGO – one of the largest and the oldest one - working for the **Education, Emancipation and Empowerment of Women** for 94 years, is setting up a new Home for elderly widows.

AIWC has been already running a Home for elderly widows and a Short Stay Home for women in distress for nearly 30 years out of a rented space in Vrindavan, since 1992. It is now in the process of building a new facility, **Aashiyana** in a town Mahavan, near Gokul in Uttar Pradesh.

Prime project of AIWC:

We, the Management of AIWC - Mrs Sheela Kakde, President, Mrs Kuljit Kaur, Secretary General and Mrs Rehana Begum, Treasurer - are delighted to announce that this upcoming **Project Aashiyana** of AIWC will be launched in a year's time and has received all necessary approvals, permissions, sanctions and is now set for its execution!

All projects of AIWC across India have positive impact on the lives of women and girls. **Project Aashiyana** also is a special one for us!

Project Details:

This project takes care of elderly widows abandoned by their families in the Vrindavan temple, or left their family on their own due to unbearable circumstances. These '**Matajis**' are brought to our Old Age Home.

We enable them to get back in good health and sound mental condition. It gets us immense satisfaction to help them become healthy and contented, and bring back the joy and comfort in their life, while they spend time with the other Matajis in the Home.

Project Plan:

Project Aashiyana is being built on a 600 sqm plot in Town Mahavan, near Chaurasi Khamba World Heritage Temple at Gokul (14 km from Vrindavan). It is a 2-storied solar-powered Green building, where multiple beneficiaries will be served.

Ground floor: On this floor, 30 '*Matajis*' will stay in 4 dormitories with a dedicated living space for each resident. There will be a common dining hall and kitchen, courtyard and a designated Prayer area, specially designed for the convenience of the elderly, with the facility of ramps, lift and ventilation. Space is also provided for House wardens and support staff.

First floor: On this floor, 30 distressed girls can be accommodated in a Shelter home. We also plan to provide a facility of Vocational centre to train youth in different skills like computers, tailoring etc. The construction will begin in June 2021 !

The support:

We are grateful to our respected Patrons, Seniors, and all members of AIWC spread over the Country who have extended their whole-hearted moral support to this project.

Dream come true project:

Personally, I would like to share that it had been our deep desire for many years that AIWC creates an independent and respectable facility for the '*Matajis*', ever since I visited them few years ago, at the present Home in Vrindavan, and saw their physical and mental state, which though improves tremendously, after staying at our Home.

Fortunately, this project now has taken a final shape due to the help and contribution from our members which has given us the reason to initiate it and I feel blessed today that I am destined to play a significant role in it.

AIWC founded pioneer institutions such as Cancer Research Institute, Chennai, Amrit Kaur Bal Vihar for Mentally Retarded Children, New Delhi, All India Women's Education Fund Association (AIWEFA) and Lady Irwin College, New Delhi set up by AIWEFA, Save the Children Committee (now Indian Council for Child Welfare) and Family Planning Centre (now Family Planning Association of India).
